**Explanation of Responses:**

The closing price of CHDN common stock on April 21, 2020, was used to determine the number of restricted stock units granted.

- The holding is comprised of restricted stock units granted for service as a director, phantom stock units granted in connection with deferred compensation elections and dividends awarded for such units. The equivalent shares of common stock related to vested units will be transferred upon the reporting person's completion of service as a director.
